From the Founding President

This is Steve Avent, Founding President of the Halifax Resolves Chapter. We're at a critical stage now, and unless we can find members willing to step forward and take on leadership roles the Chapter truly may not survive past this year.

I'd like to share with you a little bit about how the Halifax Resolves Chapter began. I was a new SAR member, living in Richmond, and had never been very active in the group. I would show up at most of the meetings and some of the chapter activities, and was satisfied with that level of involvement. My employer relocated me to NE NC in 2002, and I changed my membership to NC at that time, though I wasn't looking to get very active. The State President at that time was Joe Harris, who, unbeknownst to me, had long believed that Halifax had never gotten the recognition it deserved for its role in the Revolution, and really wanted to start a SAR chapter there.

Joe got word that a new SAR member had moved to NE NC and gave me a call, and asked me if I would be the ramrod for the formation of a new chapter in Halifax. I turned him down as I felt I was just too busy at my new position. Joe's a retired Army LTC, and a very persuasive guy, and he stayed in touch and kept working on me, and he also put me in touch with Steve Pittard (father of our current President Geoff Pittard), who was, I think, the State VP at that time. Steve's another very persuasive guy, and they promised to help and support me every step of the way, so I finally agreed.

Long story short, with Joe and Steve's help and sup-

port, the chapter was chartered and got off the ground, and has become one of the most active and accomplished small chapters in the state and at the national level. Joe and Steve's pushing me into becoming an active member turned out to be one of the best things that ever happened to me. Everyone's heard the old saying that you only get out of membership what you put in, but it's true. I became active not only at the chapter level but also the state level, and in the process made a lot of great friends, had a lot of great experiences and got a real feeling that I was a part of a group that was doing some worthwhile and important things, and making a difference.

Our chapter has been carried for many years by just a few members, but I think we've reached a point where that will have to change if the chapter is to survive. Geoff will likely not be able to serve again as President after his current term due to job and family demands, Ken can't due to health issues, and I can't as I live in the Outer Banks now and am just too far away. Even though I never had much desire to become more active in the SAR, once I did it turned out to be a great experience, and I'm sure if someone reading this decides to step forward and give it a try, he'll be glad he did.

So, what we need is this: someone who would be willing to step forward and serve as VP starting at our May or July meeting, and then agreeing to be nominated for President at our September meeting and then (if it's the will of the chapter) voted in as President in November, taking office as President in January.

RRFD Firemen Recognized at City Council Meeting

Roanoke Rapids Fire Department Lt. Ramah L. Long and Engineer Jared O. Lynch were assigned to first responder duty on November 29, 2020 when they were dispatched to 14th street at roughly 0100 hours in reference to a subject not breathing. Upon their arrival they were able to continue CPR and provide Automatic Defibrillation until EMS arrived. Once EMS arrived and were able to start administering medications by IV, it was found that the patient had regained a pulse. With the patient regaining a pulse, Fire and EMS personnel placed the patient on the stretcher and transported them to Vidant North. The patient when arriving at Vidant still had a pulse and care was transferred to emergency room staff.

Lt. Long received an oak leaf cluster for his Life Saving Medal signifying a second award and Engineer Lynch received the Life Saving Medal. The presentations were made by Halifax Resolves Chapter Compatriot Ken Wilson and Compatriot/City Council member E. C. Bobbitt.

Officer Receives Law Enforcement Commendation

On January 18, 2021, Officer Curry D. Roberts conducted a traffic stop for a vehicle speeding in the area of HWY 158 and Georgia Ave. This stop led to the discovery of Trevon Fields lifeless body in the trunk of this vehicle. The pro-activeness of Officer Curry Roberts helped the Halifax County Sheriff's Office potentially solve a murder they would not have been aware of. Officer Roberts instincts and professionalism ultimately help capture four subjects that potentially had involvement in the death of Trevon Fields. This traffic stop also yielded four handguns that would have remained on the streets illegally.



Lowes Employee Awarded SAR Life Saving Medal

On December 16, 2020 at approximately 2015 hours Mr. William Jones, Jr., was working at Lowe's Home Improvements and discovered a fellow employee unconscious, unresponsive and turning blue. Mr. Jones immediately began CPR until relieved by first responders at approximately 2030 hours. He is credited with sustaining his fellow employee's life until the arrival of first responders. The employee was transported to Vidant North Hospital with a pulse and turned over to ER doctors. The award was presented by Past President Ken Wilson.

First Responders Recognized at City Council Meeting

On December 16, 2020 at approximately 2024 Hours members of the Roanoke Rapids Police Department "D-Squad" and members of the Roanoke Rapids Fire Department were dispatched with Halifax County EMS to Lowes Home Improvements in reference to an employee that was unresponsive and turning blue. Officers Ellington, Powell and Master Officer Horne arrived in scene at 2027 hours (just 3 minutes after dispatch) and Sergeant Hundley arrived just a minute later. Sergeant Hundley responded with a department issued automated external defibrillator (AED). Fire Fighters Clements and Jarrett arrived at 2029 hours as Sergeant Hundley was hooking up the victim to the AED. Master Officer Horne and Officer Ellington were performing CPR and rescue breaths with a bag valve mask. Fire Fighters Clements and Jarrett immediately began to assist our officers in conducting "pit crew style" CPR by rotating in and out to keep from tiring one person out.

EMS had a very extended time of arrival because both of the Roanoke Rapids trucks were busy and the closest EMS crew was in Halifax. The officers and firefighters performed CPR for nearly 20 minutes before EMS arrived. Once EMS arrived, they began to administer lifesaving medicine through IV and also used their AED twice. The victim regained a pulse and was transported to Vidant North alive.

The members of the RRPD involved in this incident received the Life Saving medal. Fire Fighters Clements and Jarrett received an oak leaf cluster signifying a second award of the Life Saving Medal. Officer Ellington accepted Sgt. Hundley's award on his behalf. The presentations were made by Halifax Resolves Chapter Compatriot Ken Wilson and Compatriot/City Council member E. C. Bobbitt.

Minutes – March 13, 2021 Meeting

The March, 2021 meeting of the Halifax Resolves Chapter, NC SAR, was held on Sat., March 13, 2021 at the United Methodist Church in Halifax, NC. President Geoff Pittard called the meeting to order at 2:00 pm. An invocation was given by Carlton Garner, and then all present joined in the Pledge of Allegiance to the US Flag. President Pittard led the members in the SAR Pledge. Visitors and guests were introduced at their seat.

As the Secretary could not be present due to illness, the Treasurer read the minutes of the previous meeting, which were approved. He then gave the Treasurer's report, reporting that the Chapter had \$3,555.42 in the checking account (\$2,495.74 – general fund, \$1,462.50 – Youth Fund). President Pittard then spoke about the upcoming celebration of the adoption of the Halifax Resolves and gave a brief history of the Resolves. He then inducted the following new members:

Past Chapter President Ken Wilson was the first line endorser and pinned each new member with the SAR rosette. All inductees expressed their thanks to Ken for his help during the application process. Renny Taylor also thanked the Chapter for sponsoring him for the SAR Teacher of the Year Award.

Ken reported that he has volunteered to serve as mentor to the new members and reported that the next three chapter meetings will include training sessions, and added that the chapter is in very great need of a VP. He reported that the chapter will be participating in the dedication of a Charters of Freedom in Roanoke Rapids on 4/10/2021.

He announced that there are nine SAR compatriots buried in Louisburg and he moved that the chapter mark their graves with the appropriate SAR medallion and ceremony. He recommended that we mark five graves in the morning and four in the afternoon, and would like to do this in October or November of this year. The motion was then approved by the members.

There being no more business, Don Malcolm then led the members in the SAR Recessional, Carlton Garner gave the benediction, and the meeting was adjourned at 4:00 pm.
