It is an honor to announce that the

keynote speaker at our Annual Awards Banquet on April 18th, 2015 will be William A. "Bill" Robinson, Capt., USAF (Ret). Bill, as an Airman First Class, was a crewmember flying a rescue mission in a "Huskie" helicopter over North Vietnam when it was shot down on September 20th, 1965. For the next 2,703 days (7 years - 5 months) he would endure the horrific conditions of the infamous "Hanoi Hilton" prison. He was released on February 12th, 1973 with the distinction of being the longest held POW in U. S. military history. Shortly after his release, he was promoted to First Lieutenant before retiring as a Captain. During his career he was awarded the Air Force Cross, the Silver Star, the Legion of Merit, the Bronze Star, the POW Medal and two Purple Hearts. Earlier this year he released a book chronicling his captivity entitled "The Longest Rescue". It is a "must" read. Bill now travels the country speaking to various groups about his experiences and is well known in the military community. I hope you will make plans to attend and hear this amazing story of a modern day Patriot.

124th Annual National Congress Held in Greenville, SC

The South Carolina Society hosted the 124th Annual National Congress in Greenville on July 19-23, 2014. They put together a first-rate Congress, complete with tours of many of their historic sites. Of course, for NC compatriots, we're pretty familiar with their sites, attending many of them throughout the year, but this was a different perspective than usual, and was well worth the time.

Many NC compatriots helped the host society perform their duties, and our representation at this Congress was outstanding, filling nearly every available slot for delegates.

The Host Society Reception on Saturday was held in the same space as the hotel, across the atrium from the living spaces and was a big hit, standing room only. During the reception, an artist painted George Washington seated on his horse while we watched. Announcements and an overview of the coming events at Congress were provided by the host society.

The Color Guard held a breakfast on Sunday, followed by planning for the Memorial Service later in the day. Prior to the service, the Combined National Color Guard were reviewed by the PG and then marched down the streets of Greenville to Christ Church Episcopal, before processing into the service proper and presenting colors. Longest Surviving P.O.W. to Speak at State Convention

Many facts and stories from previous conflicts remain in the spotlight long after they have passed. One that seems to elude many is the name of the longest surviving Prisoner of War – USAF Airman First Class William Andrew Robinson. If asked, how many individuals would even be able to answer which conflict Bill was involved in? Well, here's your chance to hear his story. Captain Robinson will keynote the awards banquet in April 2015.

In April of 1965, Robinson's tour of duty in Vietnam was scheduled to last only four months. His story begins on September 20, a typical mission day in Vietnam, but by day's end, his life that would be anything but typical.

He was shot down, captured and transported to the "Hanoi Hilton". Bill was beaten, starved, and often witnessed the death of his fellow prisoners. While many POWs have been held for multiple years, he would endure SEVEN YEARS and five months of captivity (2,703 days) – the longest POW internment in US military history!

Finally released on February 12, 1973, he notes previous WWII and Korean War POWs experiences proved it was possible to survive the horrific day-to-day struggles of a POW. He has spoken many times about his ordeal. He notes that he is but one of 7.3 million who can tell his story, because he survived. Thousands upon thousands of stories died with those who did not survive.

Robinson is remembered by many as one who set the standard for maintaining honorable duty even under the most unbearable conditions. William Andrew Robinson, the longest surviving US military POW, has proven himself to be a true American Patriot.

If you would like to hear the rest of the story of how he survived this terrible time, come to the Annual Convention in April of next year. It's sure to be a moving experience for all.



September 6th, 2014 - Scott Aiken sent us this information from out of Virginia.

Washington was aware of the necessity of sea power, stating, "No land force can act decisively unless it is accompanied by maritime superiority," which brings us to the shore of the Atlantic, and the Battle of the Capes.

The naval conflict of September 5, 1781 is one of the most critical naval battles in our history and was one of the factors that assured we would win our Independence.

French Admiral de Grasse (who's statue is located at the site) sent word to French General Rochambeau in Newport, RI, that he was to assist the French and American armies.

Admiral De Grasse's fleet arrived at the Chesapeake Bay and began offloading French troops near Jamestown to join the army of General Lafayette at Williamsburg.

The British fleet arrived on September 5th, and began the slow process of moving into battle formation. Admiral De Grasse quickly organized his fleet into a line of battle and they engaged each other with a deadly volley of cannon fire. The battle lasted over two hours, with the British fleet suffering six ships damaged, 90 sailors killed and 246 wounded. The French fared better at 209 causalities and four ships damaged.

At nightfall, the two fleets disengaged to repair damage. Graves was reluctant to renew the battle. While the fleets drifted to the south watching each other over several days, Admiral De Barras' fleet arrived in the Chesapeake Bay from Newport carrying

supplies and cannon. On September 9th, Admiral De Grasse slipped away from the British and arrived the next day., now totaling 36 French ships-of-the-line.

The British fleet headed back the evening of September 10th, arriving outside the bay three days later, but they were in no condition to resume combat so they sailed to New York where they raced to repair the fleet and to get troop reinforcements to General Cornwallis at Yorktown. Slow repairs delayed the departure of the fleet until October 19th, too late to be of any help here in Virginia. The surrender took place that very day.

Admiral De Grasse sealed off Chesapeake Bay and denied General Cornwallis any opportunities for reinforcement or evacuation. The success of the French fleet in gaining control of the Chesapeake Bay also helped ensure that General Washington could use the bay to transport troops and supplies to Yorktown. Admiral De Grasse's maneuvers allowed Admiral De Barras' to arrive off Yorktown with the French heavy siege artillery, which would stir to action and prove decisive during the October siege.

British naval historian Michael Lewis, stated that "the Battle of Chesapeake Bay was one of the decisive battles of the world. Before it, the creation of the United States of America was possible; after it, it was certain."

House In The Horseshoe and Governor Benjamin Williams Remembered

State Genealogist Frank Horton arranged the conducting of an event at the "House in the Horseshoe" in Sanford NC on Saturday, August 2nd. The rains held off during the ceremony, but a downpour followed! Thanks, Clark, for putting a word in for us. Some 50 or more SAR & DAR members, color guard representatives and re-enactors participated in this new Historic Site Wreath Laying event, sponsored by the Marquis de Lafayette Chapter, in honor of Patriot Colonel Benjamin Williams who fought at Guilford Courthouse and was a later four-time governor of North Carolina.
