# Dusty Torners

This is the first in a series of articles discussing the settlement of estates in 18th and 19th century North Carolina.



As researchers, we are sometimes guilty of limiting our research to marriage records and a quick reading of a will. Most of our ancestors didn't leave wills, but they are still traceable. With or without a will, our ancestors left some sort of estate, be it large or small. So let's look at the process of dealing with estates in the 18th and 19th centuries in North Carolina. This series of articles will talk about the value of studying the entire settlement of an estate, and what information we can glean from it.

By studying an entire estate from start to finish, we can learn a lot more than what is presented in a will. Many things can happen between the writing of the will and the death of the person who wrote it. Many years might pass, and circumstances and fortunes might change. Looking only at the will and ignoring the aftermath is like reading the first chapter of a book and skipping the rest!

Here's an example in my own family. My distant uncle Marmaduke Norfleet wrote his will in Halifax County in 1802. The will indicates he was a wealthy man with a lot of farms. He left land and other property to his wife and several children, and then goes into a lengthy sermon against his daughter Lucy, who had the misfortune of eloping with a man that Daddy didn't like. Norfleet was explicit in condemning Lucy's "abhorrent" actions, and ended the discussion by leaving Lucy one shilling as "a standing memorial to an ungrateful child." What a contrast- all the other children got a farm or two, but Lucy got a shilling.

If you just read that will and go no further, you will probably shake your head and feel sorry for poor love -struck Lucy. But when we study the entire estate settlement for Norfleet, we get a different feeling. First of all, it jumps out at us that his will was written in 1802, but it was not probated until 1818. Sixteen years had passed. What happened in between? In reading the various papers connected with the probate, we learn that Norfleet's daughter Lucy died leaving an infant child, and Norfleet and his wife had several more children, including one he also named Lucy, presumably to replace the Lucy who married the wrong man. Most importantly, we learn that Norfleet was placed in an institution in Pennsylvania for depression, and was eventually declared insane by the courts. With that insanity declaration, his heirs were easily able to break his will, and his property was evenly divided among all his children, including the daughter of the unfortunate Lucy.

This is just one example I could offer to show why we should follow an estate through to the end. In the coming articles, we will discuss the different steps along the way of settling an estate and what we can learn from each of them.


# Chapter Activities
